MR. LONG: So we planned it out and our parents agreed on it that we would try to enter a Naval Academy, we tried first the Naval, and when I left here I went to Lawrence and my sister got a job in the Bowersock office and he was Senator at that time, Senator Bowersock. It was through that pull, she was the bookkeeper, secretary--got an appointment for me to Annapolis and I didn't have any high school education, I was just a freshman, so I applied, got an audience, appointment and just to make it short I didn't go up and take any official training which I

should have done, just go in without any tutoring at all, so I went to Topeka and it took me three days to take that examination.

MR. ENDACOTT: Did you take the examination the same time that Ike did? Before?

MR. LONG: I took it first.

MR. ENDACOTT: Oh, first.

MR. LONG: And 60 was my highest grade, I failed in all of them and when I got home I wrote to Ike, Dwight. I says 'please don't take that examination until you're well prepared' that's what I told him and that's the last correspondence I ever had with him.

MR. ENDACOTT: Do you have any of those letters?

MR. LONG: No.

MR. ENDACOTT: You didn't save them?

MR. LONG: I got a few letters that I got from him while he was General. I sent him congratulations on his son's graduation at West Point and he answered and I have that letter.

MR. ENDACOTT: The rest of them you didn't keep.

MR. LONG: No.

MR. ENDACOTT: Sometime you might send us a copy of that letter so we can get it into the files because we want all, everything that we can get on the history of that--

MR. LONG: How about a photostatic?

MR. ENDACOTT: That would be good along with everything that you have, John.

MR. LONG: And so when he did take it or try to take it he was too old and the Army accepted them two years older so that's why he took to the Army instead of the Navy, cause we missed the Navy. He was too old. I guess he tried to follow my advise 'don't take it until you're prepared' and then when he got prepared he was too old so he got appointed to West Point.

MR. ENDACOTT: Well, that's why he went to high school an extra year was to get that extra--you were the one that advised him to do that.

MR. LONG: No, I didn't tell him what to do but I said, 'don't take that Annapolis examination until you're well prepared'.

MR. ENDACOTT: That's what I mean, he took your advise and stayed in there and went to school. Well, you were good, that's all right.

MR. LONG: And I once come up to see him and I come up here, went down,

first thing I did after I got off the train went down over there, Mrs. Eisenhower says that Dwight isn't at home. "Well" I said, "I'd go down and visit the places I used to work" and she says, "stay here all night". So I stayed there and slept in that bed--

MR. LONG: Oh, yes, and when I come back here I took a picture of that bed.

MR. ENDACOTT: A lot of people think that we have dolled that house up but we haven't.

MR. LONG: It's just the way I made the picture.

MR. ENDACOTT: Even the pot that was under the bed, it's still there.

MR. LONG: One of the boys and I went out to look for and he slipped and fell and put his eye out.

MR. ENDACOTT: That was Earl.

MR. LONG: I don't know which one it was--

MR. LONG: I remember that just as plain as anything.

MR. ENDACOTT: Were you there when that happened?

Brown, a colored boy, sat behind me and I sat next and Dwight sat in front of me and that colored boy behind there was smarter than either one of us. He was a Sunday School teacher and he usually would get Dwight and me to come down and do the hard work. He was the State Sunday School secretary--

MR. ENDACOTT: That's right, my sister-in-law worked for him.

MR. LONG: And he was only home on Sunday's, weekends, and he taught my Sunday School class so we would go down there, Saturday's, lots of times and do his work. Well we had these potatoes to pick and were out there picking potatoes and it got kinda late and Mud Creek come along and I told Earl that the ice was off every six or eight feet off each side, you know, so there was a good place there and Ike dared me to jump in to take a swim and I looked at Dwight and he was taking off his clothes and so was I.
